

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2007 Title XX Budget)

RESOLUTION NO. 06-174

1 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**
2 **affordability and quality of child care through funding provided by the Arizona**
3 **Department of Economic Security's (A.D.E.S.) Planned Social Services Block Grant**
4 **(S.S.B.G.) Title XX Program; and**

5 **WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young**
6 **members by providing for their welfare through various programs and services**
7 **designed to meet their special needs; and**

8 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**
9 **budgets as attached and incorporated by this reference, to be effective July 1, 2006**
10 **through June 30, 2007 and request authorization to expend the funds:**

11 **1. Title XX Block Grant Program - \$120,644.00**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
13 **the FY 2007 A.D.E.S./ S.S.B.G. Title XX Block Grant Program Budget and authorizes to**
14 **expend funds for the program listed herein and as attached in the amounts indicated,**
15 **effective July 1, 2006 through June 30, 2007:**


16 **1. Title XX Block Grant Program - \$120,644.00**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
18 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**
19 **are authorized to negotiate and execute the grant, provided however, that any**
20 **amendments affecting the funds or funding levels of the grant shall be submitted for**
21 **further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st, of**
23 **MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**
25 **(d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**


