

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2007 Department of Health and Human Services Child Care and**  
**Development Fund Budgets)**

**RESOLUTION NO. 06-176**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating Child**  
4 **Care Services to provide child care services to its young tribal members; and**

5 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**  
6 **budgets as attached and incorporated by this reference, to be effective October 1,**  
7 **2006 through September 30, 2007 and requests authorization to expend funds for the**  
8 **FY 2007 Child Care and Development Fund (CCDF) in the amount of \$987,079.00 in the**  
9 **following budgets:**

10 **1. FY 2007 CCDF Mandatory Administration - \$159,882.82 + \$28,746.93 (IDC) =**  
11 **\$188,629.75.**

12 **2. FY 2007 CCDF Mandatory Program - \$387,445.53 + \$33,733.73 (IDC) = \$421,179.25.**

13 **3. FY 2007 CCDF Discretionary Administration - \$86,594.81 + \$15,569.75 (IDC) =**  
14 **\$102,164.56.**

15 **4. FY 2007 CCDF Discretionary Program - \$240,833.78 + \$34,271.66 (IDC) =**  
16 **\$275,105.44.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
18 **approves the above listed CCDF Mandatory Administration, CCDF Mandatory**  
19 **Program, CCDF Discretionary Administration, and CCDF Discretionary Program**  
20 **Budgets for period October 1, 2006 through September 30, 2007.**

21 **BE IT FURTHER RESOLVED that the Executive Branch is hereby authorized to expend funds for the**  
22 **program listed herein above and as attached in the amounts indicated, effective**  
23 **October 1, 2006 through September 30, 2007 for the FY 2007 Child Care and**  
24 **Development Fund Budgets:**

25 **1. FY 2007 CCDF Mandatory Administration - \$159,882.82 + \$28,746.93 (IDC) =**  
26 **\$188,629.75.**

27 **2. FY 2007 CCDF Mandatory Program - \$387,445.53 + \$33,733.73 (IDC) = \$421,179.25.**



5 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
6                   Nation's Official, to wit: the Chairwoman, Vice Chairman and any designated official  
7                   are authorized to negotiate and execute the grant, provided however, that any  
8                   amendments affecting the funds or funding levels of the grant shall be submitted for  
9                   further prior approval by the Tohono O'odham Legislative Council.

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>st</sup> of**  
11 **MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**  
12 **169.0 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**  
13 **(d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
14 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
16 **18, 1934 (48 Stat. 984).**


