1 **WHEREAS, the Department of Labor, Comprehensive Service Plan Annual Budget, from project**
2 **allocation in the amount of \$372,424.00 beginning July 1, 2006 and ending June 30,**
3 **2009; and**


4 **WHEREAS, the authorized expenditure period for the Department of Labor - Comprehensive**
5 **Service Plan is July 1, 2006 through June 30, 2007.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
7 **approve and authorizes the expenditure of the Employment & Training Annual**
8 **Department of Labor - Comprehensive Service Plan Budget PY 2006 in the projected**
9 **amount of \$372,424.00.**

10 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
11 **Nation's Official, to wit; the Chairwoman and Vice-Chairman and any designated**
12 **Official are authorized to negotiate and execute the contracts and plans, provided**
13 **however, that any amendment affecting the funding or funding levels of this contract**
14 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
15 **Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st. of**
17 **MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
18 **169.0 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**
19 **(d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
