

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Employment & Training Program Arizona Department of Economic Security, Adult and Youth PY 06-FY 07 Annual Contract and Budget)

RESOLUTION NO. 06-180

1 WHEREAS, the Arizona Department of Economic Security, Adult and Youth PY 06-FY 07 Annual
2 Contract and Budget have been developed with state suggested allocations in the
3 amount of \$271,069.00 beginning June 1, 2006 and ending June 30, 2009; and

4 WHEREAS, the authorized expenditure period for the Arizona Department of Economic Security,
5 Adult and Youth PY 06-FY 07 is June 1, 2006 through June 30, 2007.

6 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
7 approve and authorizes the expenditure of the Employment & Training Annual
8 Arizona Department of Economic Security, Adult and Youth PY 06-FY 07 Annual
9 Contract and Budget PY 2006 in the projected amount of \$271,069.00 with a
10 modification and contract submitted once final allocation figures have been received
11 by the program.

12 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
13 Nation's Official, to wit; the Chairwoman and Vice Chairman and any designated
14 Official are authorized to negotiate and execute the contracts and plans, provided
15 however, that any amendment affecting the funding or funding levels of this contract
16 shall be submitted for further prior approval by the Tohono O'odham Legislative
17 Council.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st of
19 MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,269.0 FOR; -0- AGAINST;
20 -0- NOT VOTING; and 171.8[05] ABSENT, pursuant to the powers vested in the Council by Section
21 1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
22 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
24 18, 1934 (48 Stat. 984).
