

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing the FY 2007 Hia-Ced O'odham Planning and Development
Budget in the amount of \$60,000.00 an Appropriation by Resolution No. 03-218)

RESOLUTION NO. 06-182

1 **WHEREAS, the Tohono O'odham Legislative Council did pass Resolution No. 03-218 approving**
2 **the land acquisition of the Robert's Property by the Tohono O'odham Nation for the**
3 **Hia-Ced O'odham, as a land base and authorized the utilization of Gaming Savings**
4 **funds in the Amount of \$1.8 million dollars to purchase the land; and**

5 **WHEREAS; the Robert's Property land acquisition was finalized on October 2, 2003 in the amount**
6 **of \$1.5 million dollars; and**

7 **WHEREAS; pursuant to Resolution 03-218, "that any funds remaining be held in an investment**
8 **savings account to fund any unforeseen expenses for The Robert's property, and that**
9 **this funding be obligated for this sole Purpose"; and**

10 **WHEREAS; the Hia-Ced O'odham Program, in collaboration with the Hia-Ced O'odham Advisory**
11 **Committee is requesting an appropriation in the amount of \$60,000.00 to continue**
12 **in the development of the Hia-Ced O'odham land base.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **appropriation of \$60,000.00 as the Hia-Ced O'odham Planning & Development FY**
15 **2007 Budget, from the 1.8 million Robert's Property land acquisition finalized on**
16 **October 2, 2003.**

17 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the**
18 **expenditure of the Planning and Development Budget in the amount of \$60,000.00 be**
19 **administered by the Hia-Ced O'odham Program in collaboration with the Hia-Ced**
20 **O'odham Advisory Committee to continue in the development of the Hia-Ced**
21 **O'odham land base.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation's officials, to wit: The Chairwoman, Vice-Chairman and any designated**
24 **official are authorized to negotiate and administer the budget, provided however,**
25 **that any amendments affecting the funds or funding levels of the budget shall be**
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**






