

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Application and Acceptance of the Grant Award for the FY 2007 Indian
Environmental General Assistance Program (GAP) grant for the TONEPA budget 11-5118)

RESOLUTION NO. 06-183

1 WHEREAS, the Tohono O'odham Nation Environmental Protection Agency (TONEPA) has applied
2 for additional funding from the US Environmental Protection Agency for the
3 continuation of the Nation's Indian Environmental General Assistance Program
4 (GAP); and


5 WHEREAS, the USEPA has allocated \$328,810.14 for the Nation's GAP, through a Cooperative
6 Agreement between the Tohono O'odham Nation and the US Environmental
7 Protection Agency, from August 1, 2006 through July 31, 2007.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts
9 and authorizes the expenditure of the FY07 GAP grant in the amount of \$328,810.14,
10 beginning August 1, 2006 through July 2007, for the TONEPA budget 11-5118.

11 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
12 Nation's Officials, to wit: the Chairwoman, Vice-Chairman and any designated
13 official are authorized to negotiate and execute the grant, provided however, that
14 any amendments affecting the funds or funding levels of the grant shall be
15 submitted for further prior approval by the Tohono O'odham Legislative Council.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st of
17 MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,082.3 FOR; -0-
18 AGAINST; 186.7 NOT VOTING; and 171.8 [05] ABSENT, pursuant to the powers vested in the Council
19 by Section 1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted
20 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
21 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
22 18, 1934 (48 Stat. 984).




