

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Application and Acceptance of the FY 2007 USEPA Brownfields**  
**128 (a) Tribal Response Grant)**

RESOLUTION NO. 06-184

1 WHEREAS, in Resolution 04-621, the Tohono O'odham Legislative Council accepted \$150,000 in  
2 funding for the continuation of the Brownfields Section 128(a) Tribal Response  
3 Program; and

4 WHEREAS, the TONEPA has applied for an additional \$80,000 for FY2007; and

5 WHEREAS, the Brownfields Section 128(a) Tribal Response Program Grant extends from October  
6 1, 2003 though September 30,2007; and

7 WHEREAS, the USEPA has set aside this amount, which will be awarded in a Cooperative  
8 Agreement between the Tohono O'odham Nation and the US Environmental  
9 Protection Agency.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts  
11 and authorizes the expenditure of the FY07by continuation Brownfields 128(a) grant  
12 of \$80,000, beginning October 1, 2006 through September 30, 2007.

13 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
14 Nation's Officials, to wit: the Chairwoman, Vice-Chairman and any designated official  
15 are authorized to negotiate and execute the grant, provided however, that any  
16 amendments affecting the funds or funding levels of the grant shall be submitted for  
17 further prior approval by the Tohono O'odham Legislative Council.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>st</sup>. of  
19 MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,269.0 FOR; -0- AGAINST;  
20 -0- NOT VOTING; and 171.8[05] ABSENT, pursuant to the powers vested in the Council by Section  
21 1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
22 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
24 18, 1934 (48 Stat. 984).
