

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
**(Approving the Tohono O'odham Tribal Employment Rights Office FY 2007 TERO/
EEOC Budget 13-1070)**

RESOLUTION NO. 06-185

1 **WHEREAS, the Tohono O'odham Legislative Council created the Tribal Employment Rights**
2 **Office in 1978 to enforce Indian Preference in employment, training, contracting,**
3 **and subcontracting; and**

4 **WHEREAS, the contract between the Equal Employment Opportunity Commission and the**
5 **Tribal Employment Rights Office has been approved by the Office of the**
6 **Chairwoman for a grant in the amount of \$25,000.00, beginning October 1, 2006**
7 **through September 30, 2007.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
9 **and approves the expenditure of the FY2007 Equal Employment Opportunity grant**
10 **in the amount of \$25,000.00, beginning October 1, 2006 through September 30, 2007,**
11 **for the Tribal Employment Rights Office budget 13-1070.**

12 **BE IT FINALLY RESOLVED by the Tohono O'odham Nation Legislative Council that the Tohono**
13 **O'odham Nation's officials, to wit: the Chairwoman and Vice Chairman is**
14 **authorized to negotiate and execute the grant, provided however, that any**
15 **amendments affecting the funding, or funding levels of the grant shall be submitted**
16 **for further prior approval by the Tohono O'odham Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21st of**
18 **MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,269.0 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and 171.8[06] ABSENT, pursuant to the powers vested in the Council by Section**
20 **1 (d)(2)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**


