

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance
- FY07 Food Distribution Program Budget - Account No. 11-1315)

RESOLUTION NO. 06-186

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2007 grant with the**
3 **United States Department of Agriculture (USDA); and**

4 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham**
5 **Nation and the people; and**

6 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to apply for FY2007 United**
7 **States Department of Agriculture funds to assist eligible individuals and families with**
8 **commodity foods; and**

9 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
10 **Division, Food Distribution Program has submitted for review and approval, the**
11 **proposal and budget in the amount of \$181,138.00.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
13 **approves and authorizes the expenditure of the attached FY07 Food Distribution**
14 **Program Budget 11-1325 in the amount of \$181,138.00.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Nation's Officials to wit: the Chairwoman and Vice-Chairman are authorized to**
17 **negotiate and execute the grant, provided however, that any amendments affecting**
18 **the funding or funding levels of the grant shall be submitted for further prior**
19 **approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST day**
21 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,269.0 FOR; -0-**
22 **AGAINST; -0-NOT VOTING; and 171.8 [05] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 1 (d)(2)& (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
24 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
25 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
26 **of June 18, 1934 (48 Stat. 984).**
