11	WHEREAS,	these Title IV-B, Subparts 1 & 2 Budgets are authorized for only a two-year				
12		expenditure period, beginning October 1, 2006 and ending September 30, 2008,				
13		funding only the two fiscal years of FY 2007 and FY 2008; and				
14	WHEREAS,	the Department of Health and Human Services has provided estimated allocation				
15		amounts for these budgets as:				
16		1. \$130,319.00 for Title IV-B, Subpart 1 Budget, Acct. 11-1335.
