

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(FY 2007 Department of Health and Human Services Title IV-B, Subparts 1 & 2 Budgets**  
**for Division of Child Welfare Services)**

**RESOLUTION NO. 06-188**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a**  
4 **Division of Child Welfare Services to intervene against child abuse and neglect and**  
5 **to promote safe and stable families; and**

6 **WHEREAS, the Title IV-B, Subparts 1 & 2 grants require a 25% match, which the Nation matches**  
7 **through the P.L. 93-638 master contract, specifically the BIA Social Services budget**  
8 **for child welfare services and the BIA ICWA budget for Family Preservation Program,**  
9 **as authorized by both P.L. 93-638 and the Department of Health and Human Services;**  
10 **and**

11 **WHEREAS, these Title IV-B, Subparts 1 & 2 Budgets are authorized for only a two-year**  
12 **expenditure period, beginning October 1, 2006 and ending September 30, 2008,**  
13 **funding only the two fiscal years of FY 2007 and FY 2008; and**

14 **WHEREAS, the Department of Health and Human Services has provided estimated allocation**  
15 **amounts for these budgets as:**

- 16 **1. \$130,319.00 for Title IV-B, Subpart 1 Budget, Acct. 11-1335.**  
17 **2. \$125,340.00 for Title IV-B, Subpart 2 Budget, Acct. 11-1336; and**

18 **WHEREAS, the Executive Branch developed and obtained committee approval of the budgets**  
19 **attached and incorporated by this reference, to be effective October 1, 2006 through**  
20 **September 30, 2007 and request authorization to expend funds over the fiscal year of**  
21 **FY 2007.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
23 **approve and authorize the Executive Branch to expend funds for the budgets**  
24 **attached, effective October 1, 2006 through September 30, 2007, in the following**  
25 **amounts:**

- 26 **1. FY07 Title IV-B, Subpart 1 Budget, Acct. 11-1335 = \$130,319.00.**  
27 **2. FY07 Title IV-B, Subpart 2 Budget, Acct. 11-1336 = \$125,340.00; and**



1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
2 Nation's officials to wit: the Chairwoman, Vice-Chairman and any designated official  
3 are hereby authorized to negotiate, execute and expend the grant, provided however,  
4 that any amendments affecting the funding or funding levels of the grant shall be  
5 submitted for further prior approval by the Tohono O'odham Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> day  
7 of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,269.0 FOR; -0-  
8 AGAINST; -0- NOT VOTING; and 171.8 [05] ABSENT, pursuant to the powers vested in the Council  
9 by Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation,  
10 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy  
11 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
12 of June 18, 1934 (48 Stat. 984).




