(Approving FY 2007 Title VI Part A, Part C - Native American Family Caregiver Support
and Nutrition Services Incentive Program (NSIP) Budgets)**

RESOLUTION NO. 06-190

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**
2 **Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Division Title VI Program has been**
4 **made possible in part by Title VI of the Older American's Act of 1978 as amended; and**

5 **WHEREAS, Title VI Part A, Part C - Native American Family Caregiver Support Program and**
6 **Nutrition Services Incentive Program (NSIP) is part of a three-year project that**
7 **commenced on April 1, 2005 and will end on March 31, 2008; and**

8 **WHEREAS, the fiscal year 2007 Title VI Program budgets have been prepared to cover the second**
9 **year of the three-year project starting April 1, 2006 to March 31, 2007:**

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation officials, to wit: the Chairwoman, Vice-Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST day of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,269.0 FOR; -0- AGAINST; -0- NOT VOTING; and 171.8 [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




