8	WHEREAS,	by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved the
9		name change of the <u>Community Based Diabetes Prevention Program</u> to the <u>Healthy</u>
10		O'odham Promotion Program; and
11	WHEREAS,	the Tohono O'odham Department of Human Services is requesting the Fiscal Year
12		2007 base budget of \$1,929,827.00 and carryover funding of \$3,529,100.56 for a total
13		budget of \$5,458,927.56.
14	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
15		authorizes the expenditure of the Fiscal Year 2007 budget of \$5,458,927.56 for the
16		Division of Health Promotion Program.
17	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
18		Nation Officials, to wit: the Chairwoman and Vice Chairman and any designated
19		Official are hereby authorized to negotiate and execute the grant, provided however,
20		that any amendments affecting the funds or funding levels of the grant shall be
21		submitted for further approval by the Tohono O'odham Legislative Council.
