4	WHEREAS,	funding for the operation of the Tohono O'odham Tuberculosis Control Services
5		Program has been provided in part through supplemental funding sources; and
6	WHEREAS,	the Division of Community Health-Tuber culosis Control Services desires to continue the Control Services
7		the services it provides to TB susceptible patients; and
8	WHEREAS,	the Tohono O'odham Tuberculosis Control Services Program has received funding
9		from the State of Arizona, Department of Health Services for its program; and
10	WHEREAS,	a budget in the amount of \$20,000 is submitted for review and approval by the
11		Department of Human Services, Tohono O'odham Nation Legislative oversight
12		committees, Health & Human Services and the Budget & Finance utilize funds to
13		continue the services it provides.
14	NOW, THER	EFORE, BE IT RESOLVED, by the Tohono O'odham Legislative Council that:
15		1. It hereby approves the funding of the Tohono O'odham Tuberculosis Control
16		Services Program from the State of Arizona Department of Health Services and
17		approves expenditures in accordance with the attached budget in the amount of
18		\$20,000.
19		2. That the duration of this contract shall be from July 01, 2004 and remain in effect
20		as long as the Arizona Department of Health Services agrees to fund the Tohono
21		O'odham Tuberculosis Control Services Program.
22	BE IT FINAI	LLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
23		Nation's Officials, to wit: The Chairwoman and Vice Chairman and any designated
24		Official are authorized to negotiate and execute this contract, provided however, that description and description description
25		any amendments affecting the funds or funding levels of the contract shall be
26		submitted for further prior approval by the Tohono O'odham Legislative Council.
