

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2007 Phoenix Indian School Trust Fund Budget for Division of**  
**Child Welfare Services)**

**RESOLUTION NO. 06-202**

1 **WHEREAS, the Tohono O'odham Nation was notified in November 1999 by the Executive Director**  
2 **of the Inter-Tribal Council of Arizona, Mr. John R. Lewis, that the Nation is scheduled**  
3 **to receive its first distribution of the Arizona Inter-Tribal Trust Fund in the amount**  
4 **of \$400,000.00 in December 1999 under Public Law 100-969, Arizona Inter-Tribal and**  
5 **Navajo Trust Fund; and**

6 **WHEREAS, by Resolution Nos. 2000-253 and 03-221, the Legislative Council approved allocations**  
7 **for all \$400,000.00 of this first distribution to fund budgets of the Department of**  
8 **Human Services Division of Child Welfare Services; and**

9 **WHEREAS, the Nation was eligible to receive the second distribution of the Arizona Inter-Tribal**  
10 **Trust Fund in the amount of \$400,000.00 for Fiscal Years 2005, 2006, and 2007; and**

11 **WHEREAS, the Department of Health and Human Services, Division of Child Welfare Services was**  
12 **allocated \$266,666.66 of the second distribution for its Fiscal Years 2005 and 2006**  
13 **Phoenix Indian School Trust Fund budgets under Resolution Nos. 04-642 and 05-577;**  
14 **and**

15 **WHEREAS, the Phoenix Indian School Trust Fund budgets have provided critical funding**  
16 **necessary for the Division of Child Welfare Services to pursue its mission to serve and**  
17 **protect the Nation's children; and**

18 **WHEREAS, by agreement with the Nation's Executive Office and the Department of Health and**  
19 **Human Services, the remaining \$133,333.33 of the second distribution of the Arizona**  
20 **Inter-Tribal Trust Fund will be committed to continue funding the Fiscal Year 2007**  
21 **budget of the Department of Health and Human Services Division of Child Welfare**  
22 **Services, for the period of October 1, 2006 – September 30, 2007.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
24 **approve and authorize the Executive Branch to expend funds for the FY2007 Phoenix**  
25 **Indian School Trust Fund budget attached, effective October 1, 2006 through**  
26 **September 30, 2007, in the amount of \$133,333.33 committed to continue funding the**  
27 **budget of the Department of Health and Human Services Division of Child Welfare**  
28 **Services.**



1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
2 Nation's officials to wit: the Chairwoman, Vice-Chairman and any designated official  
3 are hereby authorized to negotiate, execute and expend the grant, provided however,  
4 that any amendments affecting the funds or funding levels of the grant shall be  
5 submitted for further prior approval by the Tohono O'odham Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>. day  
7 of MARCH, 2006 at a meeting at which a quorum was present with a vote of 1,712.3 FOR; 421.0  
8 AGAINST; 307.5 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
9 Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted  
10 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
12 18, 1934 (48 Stat. 984).






