

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing the Planning Department Housing Rehabilitation Project Construction**  
**and Administration Budget for Fiscal Year 2007)**

RESOLUTION NO. 06-206

1 WHEREAS, the Legislative Council approved the three year funding request of \$9,405,649.93 by  
2 Resolution No. 01-661; and

3 WHEREAS, the Planning Department's Housing Rehabilitation Project has completed the  
4 rehabilitation project; and

5 WHEREAS, the Housing Rehabilitation Project will need to continue in order to follow up on  
6 warranty issues with the homes completed, this will be with identified staff; and


7 WHEREAS, the Planning Department has presented a budget for FY 2007 in the amount of  
8 \$411,624.09 as attached and was presented and approved by the Housing Committee,  
9 Commerce Committee and Budget and Finance Committee of the Tohono O'odham  
10 Legislative Council.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
12 the proposed attached budget and attachments for FY 2007 in the amount of  
13 \$411,624.09, provided that such funds shall be expended exclusively for the purposes  
14 identified in Resolution No. 01-661, as amended by Resolution No. 02-070 and  
15 pursuant to Resolution No. 02-313.

16 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
17 Nation's Official, to wit: the Chairwoman, Vice Chairman and any designated official  
18 are authorized to negotiate and execute the budget, provided however, than any  
19 amendments affecting the funds or funding levels of the budget shall be submitted  
20 for further prior approval by the Tohono O'odham Legislative Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> day  
22 of MARCH, 2006 at a meeting at which a quorum was present with a vote of 1,181.15 FOR; 379.5  
23 AGAINST; 880.15 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
24 Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted  
25 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
27 18, 1934 (48 Stat. 984).
