3	benefit of the nation and its members" provided that "[a]ll expenditures of these funds
4	shall be pursuant to appropriations or budgets" authorized by resolution or ordinance
5	(Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and
6	WHEREAS, the Legislative Branch has prepared and submitted for review and approval of its FY
7	2007 Budget; and
8	WHEREAS, the Budget and Finance Committee and the Legislative Council have reviewed the FY
9	2007 Legislative Branch Budget.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
11	approves and authorizes expenditure of the FY 2007 Legislative Branch Budget in the
12	amount of \$2,431,334.02, as per the attached budget, beginning October 1, 2006 and
13	ending September 30, 2007.
14	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22^{ND} . day
15	of MARCH, 2006 at a meeting at which a quorum was present with a vote of $1,615.1$ FOR; 155.40
16	AGAINST; 670.3 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
17	Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
18	the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
19	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
20	18, 1934 (48 Stat. 984).
