

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting and Approving the Executive Branch Fiscal Year 2007 Tribal Budget  
and Appropriating Funds in the amount of \$39,688,811.00)**

**RESOLUTION NO. 06-210**

1 **WHEREAS, the Executive Branch has prepared and presented its Fiscal Year 2007 tribal budget**  
2 **to the Tohono O'odham Legislative Council; and**

3 **WHEREAS, the Executive Branch Fiscal Year 2007 Budget for the period from October 1, 2006**  
4 **through September 30, 2007 has been presented to the Legislative Council both in**  
5 **summary as Schedule 1 as well as in detailed budgets (collectively, "Executive Branch**  
6 **FY 2007 Budget") that by this reference are all incorporated into this Resolution; and**

7 **WHEREAS, the Fire Department has been authorized by Legislative Council Resolution No. 06-**  
8 **084 to participate in the Arizona Public Safety Personnel Retirement System plan and**  
9 **requires a supplemental appropriation of \$56,272.88 to be added to its base budget**  
10 **as reoccurring funding for this purpose.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby appropriate**  
12 **\$39,688,811.00 from general fund revenues to fund the Executive Branch Fiscal Year**  
13 **2007 Budget.**

14 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby (1) adopts**  
15 **and approves the Executive Branch FY 2007 Budget in the amount of \$39,688,811.00,**  
16 **including \$56,272.88 in reoccurring funding to increase the Fire Department base**  
17 **Budget No. 01-1095, and (2) authorizes the expenditure of funds appropriated to, and**  
18 **in accordance with, the Executive Branch FY 2007 Budget.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Nation's Chairwoman, Vice-Chairman and any designated official are authorized to**  
21 **administer the Executive Branch FY 2007 Budget, provided, however, that any**  
22 **amendments affecting the funds or funding levels of the Executive Branch FY 2007**  
23 **Budget shall be submitted for prior approval by the Tohono O'odham Legislative**  
24 **Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> day**  
26 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 1,651.3 FOR; 789.5**  
27 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
28 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**






