

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Fiscal Year 2007 Budget for the Tohono O'odham Nation Justice Center**  
**and Appropriating Funds in the Amount of \$5,230,272.61)**

**RESOLUTION NO. 06-211**

1 **WHEREAS, the fiscal year 2006 will end at midnight, September 30, 2006 and all spending**  
2 **authority granted under the 2006 budgets terminate at that time; and**

3 **WHEREAS, the Judicial Branch of the Nation has prepared and presented a budget to the**  
4 **Legislative Council that reflects the needs of the Branch, a copy of the proposed said**  
5 **budget is attached hereto and incorporated herein by reference; and**

6 **WHEREAS, the proposed FY 2007 Judiciary Budget includes employees salary in the amount of**  
7 **\$3,373,678.76, plus 2.5% salary adjustment for all judicial employees salary at**  
8 **\$84,341.97, including other compensation at \$145,231.71, fringe benefits at**  
9 **\$1,117,008.26, and operational cost in the amount of \$510,011.91, totaling**  
10 **\$5,230,272.61 for FY 2007; and**

11 **WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the Legislative**  
12 **Council of the Tohono O'odham Nation have reviewed this budget and recommends**  
13 **its approval and adoption.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed**  
15 **and approved the Fiscal Year 2007 budget submitted by the Judicial Branch.**

16 **BE IT FURTHER RESOLVED that funds in the amount of \$5,230,272.61 is appropriated and**  
17 **authorized to be expended from sources of funding approved by this Council for**  
18 **support of the Fiscal Year 2007 budget of the Tohono O'odham Judicial Branch.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Nation's Judicial Officials, to wit: the Chief Judge, Deputy Chief Judge and any**  
21 **designated official are authorized to negotiate and administer this budget, provided**  
22 **however, that any amendments affecting the funds or funding levels of the budget as**  
23 **presented shall be submitted for further prior approval by this Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> day**  
26 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,104.4 FOR; -0-**  
27 **AGAINST; 336.4 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
28 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**


