9		\$1,117,008.26, and operational cost in the amount of \$510,011.91, totaling
10		\$5,230,272.61 for FY 2007; and
11	WHEREAS,	the Judiciary Committee and the Budget and Finance Committee of the Legislative
12		Council of the Tohono O'odham Nation have reviewed this budget and recommends
13		its approval and adoption.
14	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed
15		and approved the Fiscal Year 2007 budget submitted by the Judicial Branch.

18		support of the Fiscal Year 2007 budget of the Tohono O'odham Judicial Branch.
