

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2007 Bureau of Indian Affairs Budgets under the Nation's P.L. 93-638 Master Contract)**

**RESOLUTION NO. 06-212**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
 2 **Bureau of Indian Affairs under a P.L. 93-638 Master Contract; and**

3 **WHEREAS, in 2005, the Nation negotiated a P.L. 93-638 Master Contract with the Bureau of Indian**  
 4 **Affairs which remains in effect; and**

5 **WHEREAS, the Executive Branch has developed the following budgets for programs funded by**  
 6 **the BIA Master Contract effective October 1, 2006 through September 30, 2007 and**  
 7 **requests approval of the budgets and authorization to expend the funds, subject to**  
 8 **Congressional appropriation or Continuing Resolution:**

7 **WHEREAS, it is anticipated that the program budgets will be adjusted after Congress**  
8 **appropriates funding for the Bureau of Indian Affairs for FY 2007 and the FY 2007**  
9 **funding levels are provided to the Nation, and that those adjusted budgets will be**  
10 **presented to the Legislative Council for approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the BIA**  
12 **P.L. 93-638 contract program budgets listed herein, subject to later approval by the**  
13 **Legislative Council of annual funding agreements with the Bureau of Indian Affairs,**  
14 **and authorizes the programs to expend funds as budgeted, subject to Congressional**  
15 **appropriation of funding in FY 2007 or Continuing Resolution:**

14 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that any amendments to  
15 **the budgets approved pursuant to this resolution that affect the funds or funding**  
16 **levels of the budgets shall be submitted for further prior approval by the Tohono**  
17 **O'odham Legislative Council.**

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
19 **Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official**  
20 **are authorized to negotiate and execute the contract, provided however, that any**  
21 **amendments affecting the funds or funding levels of the contract P.L. 93-638 shall be**  
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> day**  
24 **of MARCH, 2006 at a meeting at which a quorum was present with a vote of 2,104.4 FOR; -0-**  
25 **AGAINST; 336.4 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
27 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**






