

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance
- FY06 Food Distribution Program Budget Amendment #1 - Account No. 11-1315)

RESOLUTION NO. 06-230

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2006 grant with the**
3 **United States Department of Agriculture (USDA); and**

4 **WHEREAS, by Resolution No. 05-566, the Tohono O'odham Legislative Council approved the FY06**
5 **Food Distribution Program budget in the amount of \$181,138.00; and**

6 **WHEREAS, Food Distribution Program funds available to the Tohono O'odham Nation for FY2006**
7 **through the USDA has been increased by \$3,937.00 from \$181,138.00 to \$185,075.00;**
8 **and**

9 **WHEREAS, Budget Amendment #1 has been submitted and has been allocated to the following**
10 **line items: Gas, Oil and Coolants \$3,229.13, and Indirect Cost \$707.87 bringing the**
11 **total budget amount to \$185,075.00; and**

12 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
13 **Division, Food Distribution Program has submitted the FY2006 Food Distribution**
14 **Program funding budget amendment No #1 in the amount of \$185,075.00 to reflect**
15 **the increase in funding, for review and approval.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 17 **1. It hereby approves and authorizes the FY2006 Food Distribution Program budget**
18 **Amendment #1 in the amount of \$185,075.00, which reflects the final allocation**
19 **award and authorizes expenditures in accordance with the attached budget.**
- 20 **2. That the Tohono O'odham Nation's official to wit: The Chairwoman, Vice-**
21 **Chairman and any designated official are hereby authorized to negotiate and**
22 **execute the grant provided however that any amendments affecting the funding**
23 **levels of this grant shall be submitted for further prior approval by the Tohono**
24 **O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 3RD day**
26 **of APRIL, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
29 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**




