

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tabling Update on Annual Leave Payout until the May 2006 General Session with Complete Listing of Appointed Positions and a Legal Opinion from the Attorney General's Office)**

LEGISLATIVE ORDER NO. 06-237

1 **WHEREAS, on April 06, 2006 the update on the status of the annual leave payout for Judicial,**
2 **Legislative and Executive Branches was scheduled for the Tohono O'odham**
3 **Legislative Council from the Chairwoman of the Tohono O'odham Nation, Vivian**
4 **Juan-Saunders; and**

5 **WHEREAS, there have been issues of concern regarding the annual leave payout for Judicial,**
6 **Legislative and Executive Branches; and**

7 **WHEREAS, due to the conflict of interest with relatives and current elected officials listed on the**
8 **proposed listing the matter was referred out to a third party for contract; and**

9 **WHEREAS, the contractor to audit this matter was Eide Bailey; and**

10 **WHEREAS, the Tohono O'odham Legislative Council was provided a memo and listing of**
11 **individuals of the Legislative, Executive and Judicial Branches who were paid out**
12 **annual leave; and**

13 **WHEREAS, the question now presented is whether the individuals were properly authorized to**
14 **receive annual leave payouts; and**

15 **WHEREAS, a motion was made and seconded to table this item until the May 2006 Session and a**
16 **complete listing of individuals of all appointed positions and a legal opinion from the**
17 **Office of Attorney General is presented for review.**

18 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council approves this**
19 **item be tabled until the May 2006 Session and a complete listing of individuals of all**
20 **appointed positions and a legal opinion from the Office of Attorney General is**
21 **presented for review.**

22 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH. Day of**
23 **APRIL, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Article VI,**
25 **Section 1(g) and Article X, Section 7 of the Constitution of the Tohono O'Odham Nation, adopted**
26 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**


