**RESOLUTION NO. 06-240**

1 **WHEREAS, the Gu-Vo District is requesting a modification to the FY'06 Budget in order to**  
2 **conduct business at their administration level; and**

3 **WHEREAS, the Gu-Vo District Administration did submit the modification to the District**  
4 **Council for review and approval; and**

5 **WHEREAS, Gu-Vo District Administration did submit their Modification No. 1 to the Tohono**  
6 **O'odham Legislative Council Budget & Finance Committee for review and**  
7 **recommendations; and**

8 **WHEREAS, the Legislative Council Budget & Finance Committee does hereby recommends**  
9 **approval to the Gu-Vo District Administration Budget FY'06 Modification No. 1.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
11 **the Gu-Vo District FY'06 Administration Budget Modification No.1, hereby**  
12 **incorporated by this reference.**

13 **BE FINALLY RESOLVED that any amendments affecting the funds or funding levels of the budget**  
14 **shall be submitted for further prior approval by the Tohono O'odham Legislative**  
15 **Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 5<sup>TH</sup>, day**  
17 **of APRIL, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**  
19 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**


