

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Budget Modification #2 for Topawa Community, Baboquivari District)

RESOLUTION NO. 06-245

1 WHEREAS, at a regular scheduled meeting on April 1, 2006, of the Baboquivari District Council,
2 the Topawa Community Representatives presented a budget modification #2-FY
3 2006 to make adjustments to salaries; and

4 WHEREAS, the budget modifications are as follows:

- 5 ▶ Salaries-610.32 to increase by \$4,830.95 with a revised amount of \$48,900.80;
- 6 ▶ Occasional Appointment-614.32 to decrease by \$1,658.80 with revised amount
7 of \$3,456.08;
- 8 ▶ Fringe Benefits-620.32 to decrease by \$1,913.09 with revised amount of
9 \$11,688.08;
- 10 ▶ Material-727.32 to decrease by \$1,285.86 with revised amount of \$1,285.86; and

11 WHEREAS, any changes made to the FY 2006 Topawa budget salaries will be retroactive from
12 October 1, 2005 to current date for employees; and

13 WHEREAS, any changes in the justifications, additions and/or transfer of funds between budget
14 line items are to be reviewed and approved by the Baboquivari District Council.

15 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council accepts and approves the Topawa
16 Community budget modification #2 to adjust salaries in the amount of \$4,830.75 and
17 salaries will be retroactive to October 1, 2005 to current date.

18 BE IT FINALLY RESOLVED that any amendments affecting the funds or funding levels of the budget
19 shall be submitted for further prior approval by the Tohono O'odham Legislative
20 Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 7TH day
22 of APRIL, 2006 at a meeting at which a quorum was present with a vote of 2,188.9 FOR; -0- AGAINST;
23 251.9 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1
24 (d)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
25 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
27 Stat. 984).
