

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment #1 to add \$50,000.00 from the General Surplus to the FY  
2006 Livestock Inspectors budget 01-1501 to increase the budget to \$282,420.33)**

**RESOLUTION NO. 06-246**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2006 Livestock Inspectors**  
2 **budget 01-1501 with Resolution 05-558; and**

3 **WHEREAS, the Nation's Executive Office has allocated a General Surplus of \$50,000.00 for the**  
4 **FY2006 Livestock Inspectors budget 01-1501; and**

5 **WHEREAS, line items 722 PROGRAM SUPPLIES, 727 BUILDING MATERIALS, and 772 RM**  
6 **BUILDING will be added to the FY2006 Livestock Inspectors budget; and**

7 **WHEREAS, the \$50,000.00 from the General Surplus will be added to the above budget line items**  
8 **for a total budget amendment of \$282,420.33; and**

9 **WHEREAS, the FY2006 Livestock Inspectors budget 01-1501 has been reviewed by the Tohono**  
10 **O'odham Legislative Agricultural Committee and the Budget and Finance**  
11 **Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 13 **1. approves the creation and addition of the above line items to the FY2006**  
14 **Livestock Inspectors budget 01-1501 on a one-time basis for FY2006.**
- 15 **2. authorizes the appropriation and expenditure of the General Surplus, in the**  
16 **amount of \$50,000.00, on a one-time basis for FY2006, to the FY2006 Livestock**  
17 **Inspectors budget 01-1501, for a total budget amendment of \$282,420.33 and in**  
18 **accordance with the budget attached hereto.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated**  
21 **official are authorized to administer the budget, provided however, that any**  
22 **amendments affecting the funds or funding levels of the budget shall be submitted**  
23 **for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 7<sup>TH</sup> day**  
25 **of APRIL, 2006 at a meeting at which a quorum was present with a vote of 1,701.65 FOR; -0-**  
26 **AGAINST; 739.15 NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**




