

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2006 Baboquivari District Administration Budget Amendment #2,  
Utilizing FY 2005 Carryover Funds)**

**RESOLUTION NO. 06-247**

1 **WHEREAS, at a regular scheduled meeting on April 1, 2006, of the Baboquivari District Council,**  
2 **the District Treasurer presented a Budget Amendment #2, utilizing FY 2005**  
3 **carryover funds in the amount of \$125,787; and**

4 **WHEREAS, the District Administration has FY 2005 carryover monies in the amount of**  
5 **\$204,946.25 and that the District Council is in agreement to utilize \$125,787.00 of the**  
6 **FY 2005 carryover funds with the understanding of the remaining FY 2005 carryover**  
7 **monies in the amount of \$79,159.24 to be utilized at a later date; and**

8 **WHEREAS, the budget amendment will supplement the FY 2006 Administration annual budget**  
9 **line items:**

- 10       ▶ **Seasonal Labor-614.32, increase by \$13,524.00 for a revised amount of \$19,600.00;**
- 11       ▶ **Insurance-630.32, increase by \$4,264.00 for a revised amount of \$13,390.80;**
- 12       ▶ **Tuition & Registration-650.32, increase by \$3,000.00 for a revised amount of**  
13       **\$13,000.00;**
- 14       ▶ **Travel Expense-660.32, increase by \$3,000.00 for a revised amount of \$13,000.00;**
- 15       ▶ **Mileage-661.32, increase by \$2,000.00 for a revised amount of \$2,800.00;**
- 16       ▶ **Utilities-710.32, increase by \$3,000.00 for a revised amount of \$10,000.00;**
- 17       ▶ **Communication-711.32, increase by \$3,000.00 for a revised amount of \$11,300.00;**
- 18       ▶ **Gas, oil, coolants-712.32, increase by \$2,000.00 for a revised amount of**  
19       **\$12,864.00;**
- 20       ▶ **Supplies other-721.32, increase by \$10,000.00 for a revised amount of \$37,588.40;**
- 21       ▶ **Capital Equipment-750.32, increase by \$79,999.00 for a revised amount of**  
22       **\$80,000.00;**
- 23       ▶ **R/M Vehicle-771.32, increase by \$2,000.00 for a revised amount of \$7,500.00; and**

24 **WHEREAS, any changes in the justifications, additions and/or transfer of funds between budget**  
25 **line items are to be reviewed and approved by the Tohono O'odham Legislative**  
26 **Council.**

27 **NOW ,THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**  
28 **approves the Baboquivari District budget modification #2 as attached hereto.**

6 **of APRIL, 2006 at a meeting at which a quorum was present with a vote of 2,247.7 FOR; -0- AGAINST;**  
7 **-0- NOT VOTING; and 193.1[08] ABSENT, pursuant to the powers vested in the Council by Section**  
8 **1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
9 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
10 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
11 **Stat. 984).**


