

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment #1 to add \$260,357.39 from General Surplus to the FY2006 Office of the Treasurer budget 01-1048 to increase the budget to \$502,696.50)**

**RESOLUTION NO. 06-268**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2006 Office of the Treasurer**  
2 **budget 01-1048 with Resolution 01-558; and**

3 **WHEREAS, the Nation's Executive Office has requested a General Surplus of \$260,357.39 for the**  
4 **FY2006 Office of the Treasurer budget 01-1048; and**

5 **WHEREAS, the following line items 721 SUPPLIES OTHER, 810 PROFESSIONAL SERVICES, 912**  
6 **BANK FEES, 750 MAJOR CAPITAL and 778 ALTERATIONS AND RENOVATIONS will be**  
7 **added to the FY06 Office of the Treasury budget; and**

8 **WHEREAS, an additional CASHIER II position has been added to assist in performing the daily**  
9 **functions of the Cashier's Office in the Office of the Treasury; and**

10 **WHEREAS, the \$260,357.39 from the General Surplus will be added to the above budget line items**  
11 **and additional compensation for a total budget amendment of \$502,696.50; and**

12 **WHEREAS, the FY06 Office of the Treasurer budget 01-1048 has been reviewed by the Budget and**  
13 **Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

15 **1. Approves the creation and addition of the following line items 721 SUPPLIES**  
16 **OTHER, 810 PROFESSIONAL SERVICES, 912 BANK FEES, 750 MAJOR CAPITAL and**  
17 **778 ALTERATIONS AND RENOVATIONS to the FY06 Office of the Treasurer budget**  
18 **01-1048 on a one-time basis for FY06; and**

19 **2. Approves the addition of a Cashier II position FY06 Office of the Treasurer budget**  
20 **01-1048 on a recurring basis; and**

21 **3. Authorizes the appropriation and expenditure of the General Surplus, in the**  
22 **amount of \$260,357.39 for a total amount of \$502,696.50 and in accordance with**  
23 **the budget attached hereto.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation's Officials, to wit: the Chairwoman, Vice-Chairman and any designated official**  
26 **are authorized to administer the budget, provided however, that any amendments**  
27 **affecting the funds or funding levels of the budget shall be submitted for further prior**  
28 **approval by the Tohono O'odham Legislative Council.**




