

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Confirming the Nomination of Mr. William L. Engles to the Economic Development**  
**Authority Board of Directors)**

**RESOLUTION NO. 06-272**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to provide for, appoint or**  
2 **provide for the appointment of, and prescribe the duties and powers of committees,**  
3 **boards, officers and agents; to establish and regulate subordinate organization for**  
4 **business purposes" (Article VI, Section 1(b), of the Constitution of the Tohono**  
5 **O'odham Nation); and**

6 **WHEREAS, the Economic Development Authority of the Tohono O'odham Nation amended and**  
7 **reinstated (EDA) Charter and Plan of Operation (Charter) was approved by Resolution**  
8 **No. 06-092; and**

9 **WHEREAS, the Charter requires that the Chairwoman of the Nation nominate Directors to the**  
10 **EDA Board of Directors, subject to confirmation by formal action of the Legislative**  
11 **Council; and**

12 **WHEREAS, the Chairwoman of the Nation has determined that Mr. William L. Engles is both**  
13 **willing and qualified to serve on the EDA Board of Directors and has nominated Mr.**  
14 **Engles to serve on the EDA Board of Directors; and**

15 **WHEREAS, vacancies on the EDA Board of Directors "shall be filled for the unexpired portion of**  
16 **the term" and Directors shall continue to serve until replaced (Charter, Section 5(a)(5)**  
17 **(c) and Section 5(a)(4); and**

18 **WHEREAS, the Legislative Council Commerce Committee and Rules Committee have both**  
19 **reviewed the Chairwoman's nomination in accordance with the Tohono O'odham**  
20 **Nation Board Appointment Guidelines (Resolution No. 03-044).**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby confirms**  
22 **the Chairwoman's nomination of Mr. William L. Engles to the Economic Development**  
23 **Authority Board of Directors for a term commencing on the effective date of this**  
24 **Resolution and expiring June 30, 2008, provided that Mr. Engles shall continue to**  
25 **serve until replaced in accordance with terms of the Charter.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02<sup>ND</sup> Day**  
27 **of MAY, 2006 at a meeting at which a quorum was present with a vote of 1,599.55 FOR; 841.25**  
28 **AGAINST; -0- NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**






