

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Mr. Edward Francisco to the Tohono O'odham Gaming Enterprise Management Board)

RESOLUTION NO. 06-277

1 **WHEREAS, the Tohono O'odham Nation's Gaming Enterprise Charter, as adopted and amended**
2 **by Resolution No. 04-513 requires the Chairman of the Nation to appoint Directors to**
3 **the Tohono O'odham Gaming Enterprise Management Board of Directors, with the**
4 **approval of the Legislative Council; and**

5 **WHEREAS, the Chairwoman of the Nation has researched, identified and determined that Mr.**
6 **Edward Francisco is both willing and qualified to continue to serve as one of the**
7 **Directors to the Tohono O'odham Gaming Enterprise Management Board; and**

8 **WHEREAS, the Chairwoman of the Nation does hereby reappoint Mr. Edward Francisco to the**
9 **Tohono O'odham Gaming Enterprise Management Board upon approval of the**
10 **Legislative Council; and**


11 **WHEREAS, the Legislative Commerce Committee and Legislative Rules Committee have both**
12 **reviewed the Chairwoman's appointment.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the Chairwoman's appointment of Mr. Edward Francisco to the Tohono O'odham**
15 **Gaming Enterprise Management Board whose term shall expire September 30, 2007.**

16 **BE IT FINALLY RESOLVED that Mr. Edward Francisco shall exercise authority granted by the**
17 **Tohono O'odham Gaming Enterprise Charter as a member of the Tohono O'odham**
18 **Gaming Enterprise Management Board.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND, Day**
20 **of MAY, 2006 at a meeting at which a quorum was present with a vote of 926.25 FOR; 662.75**
21 **AGAINST; 851.8 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**




