

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Appointment of Mr. George Miguel to the Tohono O'odham Gaming Enterprise Management Board)**

**DEFEATED**  
**RESOLUTION NO. 06-280**

1 **WHEREAS, the Tohono O'odham Nation's Gaming Enterprise Charter, as adopted and amended**  
2 **by Resolution No. 04-513, requires the Chairman of the Nation to appoint Directors**  
3 **to the Tohono O'odham Gaming Enterprise Management Board of Directors, with the**  
4 **approval of the Legislative Council; and**

5 **WHEREAS, the Chairwoman of the Nation has researched, identified and determined that Mr.**  
6 **George Miguel is both willing and qualified to serve as one of the Directors to the**  
7 **Tohono O'odham Gaming Enterprise Management Board; and**

8 **WHEREAS, the Chairwoman of the Nation does hereby appoint Mr. George Miguel to the Tohono**  
9 **O'odham Gaming Enterprise Management Board upon approval of the Legislative**  
10 **Council; and**

11 **WHEREAS, the Legislative Commerce Committee and Legislative Rules Committee have both**  
12 **reviewed the Chairwoman's appointment.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
14 **the Chairwoman's appointment of Mr. George Miguel to the Tohono O'odham Gaming**  
15 **Enterprise Management Board whose term shall expire September 30, 2008.**

16 **BE IT FINALLY RESOLVED that Mr. George Miguel shall exercise authority granted by the**  
17 **Tohono O'odham Gaming Enterprise Charter as a member of the Tohono O'odham**  
18 **Gaming Enterprise Management Board.**

19 **The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 02<sup>ND</sup>**  
20 **Day of MAY, 2006 at a meeting at which a quorum was present, and by a vote of 704.1 FOR; 799.0**  
21 **AGAINST; 937.7 NOT VOTING; and [01] ABSENT, failed to pass because it did not receive a majority**  
22 **of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'Odham**  
23 **Nation.**
