1 **WHEREAS, at a special meeting of the Baboquivari District Council on April 24, 2006, Choulic**
2 **Community Representatives did present a budget modification to their FY 2006**
3 **Budget; and**

4 **WHEREAS, the following budget line items are decreased in the total amount of \$12,424.50 and**
5 **are as follows:**

22 **and approves the Baboquivari District, Choulic Community FY 2006 Budget**
23 **Modification #2 as attached hereto.**


24 **BE IT FINALLY RESOLVED that any amendments affecting the funds or funding levels of the budget**

32 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




