1 **WHEREAS, at a special meeting of the Baboquivari District Council on April 24, 2006, Coldfields**  
2 **Community Representatives did present a budget modification to their FY 2006**  
3 **Budget; and**

4 **WHEREAS, the amount of \$7,000.00 will decrease the following line item:**

5 **#31-7004-852.32 - Donation \$7,000.00**

6 **with a revised amount of \$13, 358.72; and**

7 **WHEREAS, the amount of \$7,000.00 will increase the following line item:**

8 **#31-7004-810.32 - Professional Services \$7,000.00**

9 **with a revised amount of \$14, 995.61; and**


10 **WHEREAS, the budget modification does not change the Coldfields Community FY 2006 base**  
11 **budget of \$109,842.88.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**  
13 **and approves the Baboquivari District, Coldfields Community FY 2006 Budget**  
14 **Modification #3 as attached hereto.**

15 **BE IT FINALLY RESOLVED that any amendments affecting the funds or funding levels of the budget**  
16 **shall be submitted for further prior approval by the Tohono O'odham Legislative**  
17 **Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> day**  
19 **of MAY, 2006 at a meeting at which a quorum was present with a vote of 2,001.4 FOR; -0- AGAINST;**  
20 **439.4 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section**  
21 **1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**


