

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 06-295, Approving the Department of Information and Technology
Budget Amendment No. 1 from General Surplus in the Amount of \$270,000)

RESOLUTION NO. 06-296

1 **WHEREAS, pursuant to Legislative Council Resolution No. 97-082, the Department of**
2 **Information and Technology ("DoIT") was created and established under the General**
3 **Support Services also known as the Administrative Support Offices, to provide**
4 **consultation and support to the Executive Office and Departments for information**
5 **technology solutions that will increase align its technology with common business**
6 **processes; and**

7 **WHEREAS, the DoIT did prepare and present a Fiscal Year 2006 budget amendment for its budget**
8 **(01-1021) in the amount of \$270,000, as attached and incorporated by this reference,**
9 **for the purpose of improving and streamlining accounting processes in relation to**
10 **human resource management; and**

11 **WHEREAS, the \$270,000 from the General Surplus will be added for a total budget amendment**
12 **of \$270,000 on a one time basis; and**

13 **WHEREAS, the Legislative Committee of Budget and Finance, and the Executive Office of the**
14 **Chairwoman, recommend approval of the Budget Amendment No. 1 with**
15 **corresponding budget.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 17 **1. Approves the attached DoIT Budget Amendment No.1 on a one time basis for the**
18 **purpose of improving and streamlining accounting processes in relation to**
19 **human resource management; and**
20 **2. Authorizes the appropriation and expenditure of the General Surplus, in the**
21 **amount of \$270,000 for one time use and in accordance with the budget attached**
22 **hereto.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Tohono**
24 **O'odham Nation Chairwoman and Vice-Chairman and any designated official to**
25 **administer the budget, provided however, that any amendments affecting the**
26 **funds or funding levels of the budget shall be submitted for prior approval by the**
27 **Tohono O'odham Legislative Council, and further provided that each branch of**
28 **the Nation's government shall retain authority to adopt and enforce that**

1 branch's personnel policies, including its attendance and time calculation
2 procedures and rules.

3 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD day**
4 **of MAY, 2006 at a meeting at which a quorum was present with a vote of 891.05 FOR; 848.45**
5 **AGAINST; 171.8 NOT VOTING; and 529.5 [09] ABSENT, pursuant to the powers vested in the**
6 **Council by Section 1(d)(2) and 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham**
7 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
8 **Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
9 **of the Act of June 18, 1934 (48 Stat. 984).**






