

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 3 to Attorney Contract with the Law Firm of Graham & Dunn, P.C.)**

RESOLUTION NO. 06-299

1 WHEREAS, pursuant to Resolution No. 03-186, the Tohono O'odham Legislative Council approved  
2 a line of credit to finance the expansion of gaming activity pursuant to the 2002  
3 Compact; and

4 WHEREAS, pursuant to Resolution 04-129, an Attorney Contract in the amount of \$100,000 was  
5 approved with the law firm of Graham & Dunn, P.C. (the "Attorneys") and funded  
6 under the line of credit for the period ending on May 1, 2005 ("Amendment No. 1"); and

7 WHEREAS, pursuant to Resolution No. 05-308, the Tohono O'odham Legislative Council approved  
8 Amendment No. 2 to the Attorney Contract with the Attorneys which extended the term  
9 of the Attorney Contract through May 1, 2006; and

10 WHEREAS, the Attorney General recommends an extension of the Attorney Contract for the period  
11 from May 1, 2006 to April 30, 2007 ("Amendment No. 3").

12 NOW, THEREFORE, BE IT RESOLVED THAT:

- 13 1. The Tohono O'odham Legislative Council approves Amendment No. 3 to the  
14 Attorney Contract with Graham & Dunn, P.C., in the form attached hereto, which  
15 extends the term of the Attorney Contract for the period from May 1, 2006 to April  
16 30, 2007.
- 17 2. The Chairwoman of the Nation is authorized and directed to execute Amendment  
18 No. 3 to the Attorney Contract with Graham & Dunn, P.C.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> day  
20 of MAY, 2006 at a meeting at which a quorum was present with a vote of 2,124.75 FOR; -0- AGAINST;  
21 316.05 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section  
22 1(d)(2) and Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted  
23 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
24 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
25 18, 1934 (48 Stat. 984).
