

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Approving the Community Financial Support donation from the Tohono O'odham Gaming Enterprise for KOHN 91.9 FM and approving Budget Amendment #2, creating a new line item and authorizing the expenditure of funds in the amount of \$3,600)

RESOLUTION NO. 06-311

1 **WHEREAS, KOHN 91.9 FM is eligible to apply for funding from the Corporation for Public**
2 **Broadcasting; and**

3 **WHEREAS, one of the eligibility criteria is that KOHN 91.9 FM must meet its community financial**
4 **support of at least \$3,600 which may be community donations, underwriting and/or**
5 **membership fees; and**

6 **WHEREAS, appropriations from the Tohono O'odham Nation, as the licensee, does not qualify as**
7 **Community Financial Support; and**

8 **WHEREAS, KOHN 91.9 FM has been approved for a donation from the Tohono O'odham Gaming**
9 **Enterprise in the amount of \$3,600; and**

10 **WHEREAS, KOHN 91.9 FM Budget Amendment #2 is requesting to create a new line item (856 Client**
11 **Support) in the current operating FY 06 budget (attached) to support its efforts in**
12 **providing internship training opportunities to local members; and**

13 **WHEREAS, KOHN 91.9 FM has presented to the Cultural Preservation Committee and the Budget**
14 **and Finance Committee.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **accept, approve, and authorize:**

- 17 **1. The expenditure of funds from a donation by the Tohono O'odham Gaming**
18 **Enterprise with the attached budget in the amount of \$3,600.**
- 19 **2. That the Community Financial Support funds in the amount of \$3,600 will increase**
20 **KOHN 91.9 FM's FY06 Operating Budget from \$484,698.05 to \$488,208.05.**
- 21 **3. Creation of new line item 856 Client Support.**
- 22 **4. That this is a one-time budget amount which will revert to the base budget in the**
23 **next fiscal year.**

24 **BE IT FINALLY RESOLVED that amendments affecting the funding levels will be submitted for**
25 **further prior approval by this Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
27 **of MAY, 2006 at a meeting at which a quorum was present with a vote of 1,318.5 FOR; 379.5 AGAINST;**
28 **575.4 NOT VOTING; and 167.4 [06] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 1(c)(2) and Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation,**
30 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
31 **Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
32 **of June 18, 1934 (48 Stat. 984).**






