14		\$26,000 for FY 2006.

16		it hereby approves and adopts the continued supplemental funding for the Tribal			
17		Employment Rights Office from the Equal Employment Opportunity Commission			
18		from \$25,000 with an increase of \$1,000 to adjust the FY 2006 budget in the			
19		amount of \$26,000, which is also cost shared with the Tribal Budget Account No. 01-			
20		1070.
