

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Tribal Employment Rights Office FY – 2006 EEOC
Budget Modification/Amendment No. 1)

RESOLUTION NO. 06-333

1 **WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office since**
2 **1978 and has successfully met the needs of the Tohono O'odham Nation; and**

3 **WHEREAS, the funding for the Tohono O'odham Nation Tribal Employment Rights Office has**
4 **been supplemented by the Equal Employment Opportunity Commission in the**
5 **amount of \$25,000.00; and**

6 **WHEREAS, the continued operation of the Tribal Employment Rights Office is to increase**
7 **employment of Indians and eradicate employment discrimination on and near the**
8 **Tohono O'odham Nation; and**

9 **WHEREAS, the contract between the Equal Employment Opportunity Commission and the**
10 **Tohono O'odham Tribal Employment Rights Office has been approved by the Office**
11 **of the Chairwoman in the amount of \$25,000.00; and**

12 **WHEREAS, the contract between the Equal Employment Opportunity Commission and the**
13 **Tohono O'odham Tribal Employment Rights Office has increased from \$25,000 to**
14 **\$26,000 for FY 2006.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that**
16 **it hereby approves and adopts the continued supplemental funding for the Tribal**
17 **Employment Rights Office from the Equal Employment Opportunity Commission**
18 **from \$25,000 with an increase of \$1,000 to adjust the FY 2006 budget in the**
19 **amount of \$26,000, which is also cost shared with the Tribal Budget Account No. 01-**
20 **1070.**

21 **BE IT FURTHER RESOLVED that the duration of this grant shall commence on October 1, 2005**
22 **through September 30, 2006.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Nation Legislative Council that the Tohono**
24 **O'odham Nation's officials, to wit: the Chairwoman and Vice Chairman is authorized**
25 **to negotiate and execute the grant, provided however, that any amendments affecting**
26 **the funding, or funding levels of the grant shall be submitted for further prior**
27 **approval by this Council.**




