

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to amend the scope of work for the FY2006 Range Conservation and
Management Program Southern Arizona Water Rights Settlement Act Heavy
Equipment budget 21-1526)

RESOLUTION NO. 06-336

1 **WHEREAS, pursuant to Resolution No. 05-724, the Tohono O'odham Legislative Council**
2 **authorized the appropriation of \$1,482,255.80 from the interest of the Southern**
3 **Arizona Water Rights Settlement Act (SAWRSA) to purchase recently used and new**
4 **heavy equipment to mitigate flooding and drought issues on the Nation; and**

5 **WHEREAS, the Nation's Range Conservation and Management Program is requesting that the**
6 **Tohono O'odham Legislative Council approve changes in the type of heavy equipment**
7 **to be purchased; and**

8 **WHEREAS, this budget has been reviewed by the Tohono O'odham Legislative Water Resources**
9 **Committee, the Agricultural Committee, and the Budget and Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes and**
11 **approves the changes in the type of heavy equipment to be purchased for the FY2006**
12 **Range Conservation and Management Program SAWRSA Heavy Equipment budget 21-**
13 **1526, in accordance with the budget attached hereto.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated**
16 **official are authorized to negotiate and execute the budget, provided however, that**
17 **any amendments affecting the funds or funding levels of the budget shall be**
18 **submitted for further prior approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH of**
20 **JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
22 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**


