

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Budget Amendment No. 1 for the Tohono O'odham Nation Police Department Ranger Program 638 BIA Contract to Establish 712 Gas, Oil and Coolants)

RESOLUTION NO. 06-340

1 **WHEREAS, the Tohono O'odham Nation under the 638 BIA Master Contract contracts its own Law**
2 **Enforcement, Corrections and Ranger Programs, and**

3 **WHEREAS, TONPD has savings derived from vacant positions leaving five (5) months salary**
4 **available for new Rangers; and**

5 **WHEREAS, the program has identified the needs to utilize these salary savings for Gas, Oil and**
6 **Coolants for Ranger Vehicles; and**

7 **WHEREAS, in order to purchase essential fluids for Ranger vehicles a line item for 712-Gas, Oil**
8 **and Coolants needs to be established; and**

9 **WHEREAS, under the FY 2006 BIA 638 Ranger Contract Account No. 10-1092 there is no line item**
10 **for 712-Gas, Oil and Coolants.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it**
12 **hereby approves and authorizes Budget Amendment No. 1 for TONPD Law**
13 **Enforcement Ranger Program BIA 638 Contract Budget account no. 10-1092 and the**
14 **establishment of line item 712-Gas, Oil and Coolants.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Vice Chairman is hereby authorized**
16 **to negotiate and execute the budget provided and that any amendments affecting the**
17 **funding or funding levels of this budget shall be submitted for approval to the Tohono**
18 **O'odham Nation Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day**
20 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,050.05 FOR; -0- AGAINST;**
21 **390.75 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1**
22 **(d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
