


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Budget Amendment No. 2 for Tohono O'odham Nation Police
Department Corrections Program 638 BIA Contract to Establish 712-Gas, Oil and
Coolants and 850-Food)**

RESOLUTION NO. 06-341

- 1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Corrections and**
2 **Ranger Programs under the 638 BIA Master Contract; and**
3 **WHEREAS, TONPD has savings derived from vacant positions leaving five (5) month salary**
4 **available for new Corrections Personnel; and**
5 **WHEREAS, the program has identified the needs to utilize these salary savings for Gas, Oil and**
6 **Coolants for Corrections vehicles and Food for inmates; and**
7 **WHEREAS, in order to purchase essential fluids for Corrections vehicles a line item for 712-Gas,**
8 **Oil and Coolants needs to be established; and**
9 **WHEREAS, in order to purchase food for inmates a line item for 850-Food needs to be**
10 **established; and**
11 **WHEREAS, under the FY 2006 BIA 638 Corrections Budget there are no line items for 712-Gas, Oil**
12 **and Coolants and 850-Food.**
13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it**
14 **hereby accepts, approves and authorizes Budget Amendment No. 2 for TONPD**
15 **Corrections Program BIA 638 contract budget account no. 10-1093.**
16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby approves the**
17 **establishment of line items 712-Gas, Oil and Coolants and 850-Food.**
18 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Vice Chairman is hereby authorized**
19 **to negotiate and execute the budget provided that any amendments affecting the**
20 **funding or funding levels of this budget shall be submitted for approval by the**
21 **Tohono O'odham Nation Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH. Day**
23 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
25 **& (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
