(Directing the Treasurer's Office to Transmit Returned 12% Grant Funding to the Arizona Benefits Fund)

1	WHEREAS,	as part of Section 12 of the Tohono O'odham Nation's Gaming Compact, the Nation					
2	:	must annually make certain tribal contributions to cities towns or counties for the					
3		benefit of the general public; and					
4	WHEREAS,	on October 25, 2005, the Legislative Council did approve various grant agreements					
5		to make part of the fiscal year 2005 12% distribution, through Resolution 05-647,					
6		including one grant to the Green Valley Community Coordinating Council (GVCCC)					
7		through the Town of Sahuarita; and					
8	WHEREAS,	due to unforeseen circumstances, the GVCCC was not able to use the \$44,000 in grant					
9		funding awarded to them, and pursuant to Resolution No. 06-293 the Legislative					
10		Council did rescind that portion of Resolution 05-647 approving a Grant-in-Aid					
11		Agreement for the benefit of the GVCCC; and					
12	WHEREAS,	the GVCCC has subsequently returned the grant funding through a check issued to					
13		the Nation, which was provided to the Treasurer's Office to hold until further					
14		direction from the Legislative Council.					
15	NOW, THER	NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council hereby directs					
16		the Nation's Treasurer's Office to issue a check in the amount of \$44,000.00 to the					
17		Commerce and Economic Development, Arizona Benefit's Funds; and further directs					
18	the Treasurer's Office to deposit the returned funding from the GVCCC into the						
19		general account.
