

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Transfer of Insurance Payments from the Nation's Insurance
Account to NRD-SWMP Revenue Account and the Approval of Budget
Amendment & Modification #1 for 83-0003)

RESOLUTION NO. 06-363

1 WHEREAS, the Tohono O'odham Legislative Council approved the creation of a dedicated
2 revenue account for the deposit of funds received by the Tohono O'odham Nation
3 Solid Waste Management Program with the passage of Resolution No. 05-558; and

4 WHEREAS, the SWMP has had one vehicle accident in FY 2006 that was declared a total loss by the
5 Nation's Insurance Company and the amount of the insurance settlement is
6 \$19,225.95; and


7 WHEREAS, the SWMP has replaced the totaled pick-up truck with funds from 83-0003-750 to
8 maintain consistent, reliable service.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
10 the transfer of \$19,225.95 from the Insurance Account to the NRD-Solid Waste
11 Revenue Account 83-0003-750 in FY-2006 as detailed in the attached Budget
12 Amendment and Modification #1, which is hereby approved .

13 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
14 Nation's Officials, to wit: the Chairwoman, Vice-Chairman, and any designated
15 official are authorized to execute the budget, provided however, that any
16 amendments affecting the funds or funding levels of the budget be submitted for
17 further approval by the Tohono O'odham Legislative Council

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day
19 of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,273.4 FOR; -0- AGAINST;
20 -0- NOT VOTING; and 167.4 [05] ABSENT, pursuant to the powers vested in the Council by Section
21 1 (d)(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
22 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
24 18, 1934 (48 Stat. 984).


