

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Law Firm of Chandler & Udall, LLP)

RESOLUTION NO. 06-370

1 **WHEREAS, pursuant to Resolution No. 05-700, the Tohono O'odham Legislative Council approved**
2 **an Attorney Contract with the law firm of Chandler & Udall, LLP to review the draft**
3 **Water Code and prepare any regulations required thereunder; and**

4 **WHEREAS, additional time is required to complete the review of the draft Water Code, any**
5 **related regulations under the Code and the District Water Advisory Committee**
6 **Bylaws; and**

7 **WHEREAS, the District Water Advisory Committee proposes an Attorney Contract with the law**
8 **firm of Chandler & Udall, LLP in the amount of \$15,000 for the period from**
9 **execution by all parties ending September 30, 2006; and**

10 **WHEREAS, there is sufficient funds available in the appropriated SAWRSA Trust Fund interest to**
11 **the District Water Advisory Committee's budget line item No. 810-Professional**
12 **Services to provide for this contract; and**

13 **WHEREAS, the Water Resources, Domestic Affairs and Budget and Finance Committees of the**
14 **Tohono O'odham Legislative Council recommend approval of an Attorney Contract**
15 **with the law firm of Chandler & Udall, LLP in the amount of \$15,000 for the period**
16 **from the date of execution by all parties ending September 30, 2006.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
18 **the Attorney Contract with the law firm of Chandler & Udall, LLP for the period from**
19 **execution by all parties ending September 30, 2006 in the amount of \$15,000.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation's Official, to wit: the Chairwoman, Vice Chairman and any designated official**
22 **are authorized to negotiate and execute the contract, provided however, that any**
23 **amendments affecting the funds or funding levels of the budget, shall be submitted**
24 **to Tohono O'odham Legislative Council for further prior approval.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
26 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 1,321.1 FOR; 344.6**
27 **AGAINST; 421.0 NOT VOTING; and 354.1 [06] ABSENT, pursuant to the powers vested in the Council**
28 **by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**






