

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 06 Department of Human Services – Community Counseling and  
Relations (CCRS) Savings Budget Mod/Amendment No. 1 (Account 10-1450) to  
increase the Indirect Cost Rate from 17.1% to 17.98%)**

**RESOLUTION NO. 06-381**

1 **WHEREAS, the Tohono O'odham Nation did renegotiate the indirect cost rate to apply to the**  
2 **fiscal year 2005-2006; and**

3 **WHEREAS, the new indirect cost rate has been raised from 17.1% to 17.98%; and**

4 **WHEREAS, the new indirect cost rate will be applied to the 2005-2006 fiscal year and to future**  
5 **budgets until such time as a new rate is negotiated and accepted; and**

6 **WHEREAS, the attached amended budget grand total amount has increased from \$13,377.24 to**  
7 **\$13,471.87; and**


8 **WHEREAS, the attached budget has been amended to apply the new indirect cost rate and**  
9 **adjusts other line items to cover anticipated over expenditures.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
11 **approve the amended budget attached incorporating the new indirect cost rate of**  
12 **17.98%.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
14 **Nation officials, to wit: the Chairwoman and Vice Chairman and any designated**  
15 **official are hereby authorized to negotiate and execute the grant, provided however,**  
16 **that any amendments affecting the funds or funding levels of the grant shall be**  
17 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup> Day**  
19 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**  
20 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1**  
21 **(d)(2) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat. 984).**
