(Approval of the FY 06 DOJ STOP Violence Against Indian Women Discretionary  
Grant Budget Modification #01 (Account 11-1421) to increase the Indirect Cost  
Rate from 17.01% to 17.98%.)**

**RESOLUTION NO. 06-384**

1 **WHEREAS, the Tohono O'odham Nation did negotiate the indirect cost rate to apply to the fiscal**  
2 **year 2005-2006; and**

3 **WHEREAS, the new indirect cost rate has been raised from 17.01% o 17.98%; and**

4 **WHEREAS, the new indirect cost rate will be applied to 2005-2006 fiscal year and to future budgets**  
5 **until such time as a new rate is negotiated and accepted; and**


6 **WHEREAS, the attached budget has been amended to apply the new indirect cost rate and adjusts**  
7 **other line items to cover anticipated over expenditures.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
9 **approve the amended budget attached incorporating the new indirect cost rate of**  
10 **17.98%.**

11 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
12 **Nation officials, to wit: the Chairwoman and Vice Chairman and any designated**  
13 **official are hereby authorized to negotiate and execute the grant, provided however,**  
14 **that any amendments affecting the funds or funding levels of the grant shall be**  
15 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup> Day**  
17 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,247.7 FOR; -0- AGAINST;**  
18 **-0- NOT VOTING; and 193.1 [05] ABSENT, pursuant to the powers vested in the Council by Section**  
19 **1 (d)(2) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**


