7	adjustments to other line items to cover anticipated over expenditures.

9	approve the amended budget attached incorporating the new indirect cost rate of
10	17.98%.

13	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
14	Nation officials, to wit: the Chairwoman and Vice Chairman and any designated
15	official are hereby authorized to negotiate and execute the grant, provided however,
16	that any amendments affecting the funds or funding levels of the grant shall be
17	submitted for further prior approval by the Tohono O'odham Legislative Council.
