RESOLUTION NO. 06-385

1 **WHEREAS, the Tohono O'odham Nation did negotiate the indirect cost rate to apply to the fiscal**
2 **year 2005-2006; and**

3 **WHEREAS, the new indirect cost rate has been raised from 17.01% o 17.98%; and**

4 **WHEREAS, the new indirect cost rate will be applied to 2005-2006 fiscal year and to future budgets**
5 **until such time as a new rate is negotiated and accepted; and**

6 **WHEREAS, the attached budget has been amended to apply the new indirect cost rate and**
7 **adjustments to other line items to cover anticipated over expenditures.**


8 **NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
9 **approve the amended budget attached incorporating the new indirect cost rate of**
10 **17.98%.**

11 **BE IT FURTHER RESOLVED that the attached budget reflects a new line item for lease and**
12 **rentals.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
14 **Nation officials, to wit: the Chairwoman and Vice Chairman and any designated**
15 **official are hereby authorized to negotiate and execute the grant, provided however,**
16 **that any amendments affecting the funds or funding levels of the grant shall be**
17 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH Day**
19 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 2,247.7 FOR; -0- AGAINST;**
20 **-0- NOT VOTING; and 193.1 [05] ABSENT, pursuant to the powers vested in the Council by Section**
21 **1 (d)(2) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
