

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 06 Department of Health & Human Services – Tuberculosis (TB)
Control Services Program - State Budget Modification/Amendment No. 1 Account
Number 12-1410 to increase the Indirect Cost Rate from 17.1% to 17.98%)**

RESOLUTION NO. 06-389

1 **WHEREAS, the Tohono O'odham Nation did re-negotiate the indirect cost rate to apply to fiscal**
2 **year 2005-2006; and**

3 **WHEREAS, the new indirect cost rate has been raised from 17.1% to 17.98% effective October 1,**
4 **2005; and**

5 **WHEREAS, the new indirect cost rate will be applied to the 2005-2006 fiscal year beginning**
6 **October 1, 2006, until such time a new rate is negotiated and accepted; and**

7 **WHEREAS, failure to correct the approved rate will not allow the Nation to report the under**
8 **recovery in future Indirect Cost Rate proposals; and**

9 **WHEREAS, the attached budget has been amended to apply the new indirect cost rate.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **approve the amended budget attached incorporating the new indirect cost rate of**
12 **17.98%.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
14 **Nation officials, to wit: the Chairwoman and Vice Chairman and any designated**
15 **official are hereby authorized to negotiate and execute the grant, provided however,**
16 **that any amendments affecting the funds or funding levels of the grant shall be**
17 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH Day**
19 **of JUNE, 2006 at a meeting at which a quorum was present with a vote of 1,499.95 FOR; -0- AGAINST;**
20 **940.85 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section**
21 **1 (d)(2) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**




