NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:

- The attached FY2006 Third Party Revenue Budget in the increased amount of \$148,972.03 to supplement the FY2006 Department of Health and Human Services, Division of Behavioral Health is hereby approved.
- 2. Approves the addition of the cost-shared Project Administrator position at 25% or \$3,715.41 prorated from June 19, 2006 through September 30, 2006 and fringe benefits to reflect the salary. Cost share with MOH 50% and HOPP 25% to work on and complete our SMI modular project for this FY2006; and increase \$8,000.00 line item Special Activities to cover communities activities.
- 3. The Treasurer or other authorized officials of the Tohono O'odham Nation are hereby authorized to deposit the above-described third party collections into Third Party Revenue Budget Account No. 18-1429 and expend such funds in an amount not to exceed \$148,972.03 to supplement the Division of Behavioral Health FY2006 budgets.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official are authorized to negotiate and execute the grant, provided however, that any amendments affecting the funds or funding levels of the grant shall be submitted for further prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH.</sup> Day of <u>IUNE, 2006</u> at a meeting at which a quorum was present with a vote of <u>2,440.80</u> FOR; <u>-0-AGAINST</u>; <u>-0-NOT VOTING</u>; and <u>[04]</u> ABSENT, pursuant to the powers vested in the Council by Section 1 (<u>d)(2) and (f)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
